Our policy engagements aim to create a level playing field for the palm oil industry on sustainability and strengthen government-to-government collaboration on sustainable trade.




Palm Oil Market in India

India is the world's largest importer of palm oil and consumes **11% of global production.**

Annual consumption in India at **8.9 MMT** significantly exceeds domestic production, which stands at **0.3 MMT**. India is currently importing palm oil and its derivatives mainly from **Indonesia and Malaysia ,** global deforestation hotspots.

IDH hosted a first of its kind public and private stakeholders consultation on responsible sourcing of edible oils in India where Shri Hardeep Singh, Additional Director General of Foreign Trade delivered the keynote address.



NITI Aayog

IDH is working with key importers and NITI Aayog's trade and commerce team to build policy recommendations feeding into national development priorities for the various departments of the Government of India.

Presently, the Markets team is working in collaboration with key departments on policy briefings and papers focussed on imports, trade and production of palm oil to build out a minimum sustainability criteria for the import of palm oil into the country, as a strong foundation to help shape the domestic production agenda. We bring our expertise in sustainable trade of palm oil, having worked in the EU market and production geographies of Indonesia and Malaysia to advise on progressing India's commitments on SDGs, regional trade and reducing the country's ecological footprint.
