

Description:

In this event, the Netherlands and UK, the State of Mato Grosso and the private sector will demonstrate their effective business case for international cooperation that has made agricultural production more sustainable and improved conservation of the Amazon rainforest in Mato Grosso (Brazil). The donor countries will share why they decided to invest in Mato Grosso, and the State Government, the PCI Institute and the private sector will share their role in implementing the coordinated efforts as part of this partnership.

The coordinated investments by four national governments (the Netherlands, the United Kingdom, Germany and Norway) and a subnational government (Mato Grosso, Brazil) over five years has successfully reduced deforestation rates. After the State of Mato Grosso launched the Produce, Conserve and Include Strategy at COP21 in Paris in 2015, the four governments supported and invested in the strategy in 2016 and 2017 through the ISLA, NICFI and REM programs.

The partnerships have strengthened the capacity of public bodies including the State Environment Secretary in command-and-control activities and supported enabling conditions to improve the sustainability in the state's main commodity chains and including indigenous people in land-use governance decision-making.

During the period 2015-2020, deforestation rates in Mato Grosso were significantly lower than the average trend from other Legal Amazon States. While the Legal Amazon States registered an increase in the annual deforestation rates of 75% from 2015 to 2020, Mato Grosso maintained it at 11%.

In 2020, a Strategic Committee to Combat Illegal Deforestation, Illegal Forest Exploration and Forest Fires - CEDIF-MT, presided by the Governor of the State defined a plan of action. As a result, in 2020, 6.891 deforestation alerts were detected covering 680 thousand hectares.

Integrated operations between SEMA and other state agencies were coordinated to stop deforestation in the field. The alerts led to a record R\$ 3,8 billion in fines issued by the State Secretary of Environment - SEMA and other government agencies. As a result, DETER alerts for deforestation have systematically been in lower levels comparing to previous years, with a reduction of 21.7% in the alerts from August 2020 until July 2021.

National Initiatives for Sustainable and Climate Smart Oil Palm Smallholders

Millions of smallholders and workers earn their livelihoods in the palm oil sector, a sector that significantly contributes to food security, employment, gross domestic product (GDP) and the balance of trade of many producing countries. The global expansion of this sector is associated with significant sustainability challenges.

The Sustainable Trade Initiative (IDH) and Solidaridad believe there is a solution. Together, they have designed a new way to enable palm oil producing countries to notably contribute to the Sustainable Development Goals (SDGs) and the Paris Agreement. With support from the Government of the Netherlands, four National Initiatives for Sustainable Climate Smart Oil Palm Smallholders (NI-SCOPS) have been set up in cooperation with the governments of Indonesia, Malaysia, Nigeria and Ghana.

The national initiatives are collaborations between consuming and producing countries to support smallholders to transition to more sustainable forms of production and improve their livelihoods, thereby contributing to climate change mitigation and adaptation. In this event, the participating governments will share examples of the work that has been carried out since the inception of the National Initiatives in 2019 and the panel will explore the benefits of supporting smallholders to transition to sustainable production models, how the international community can work together to address the most pressing challenges, and possible ways to lift barriers to scale up.




Main COP26 sites in Glasgow


