MESSAGE FROM THE MINISTER OF WATER AND FORESTS

Resting on the strength of Côte d'Ivoire's stated ambition to preserve, rehabilitate and expand forests on its territory, the Government of Côte d'Ivoire signed a convention on November 16th, 2017, in Bonn, Germany, on the Framework for Common Action of the Cocoa and Forests Initiative, with companies in the cocoa and chocolate industry.

The main objective of the Cocoa and Forests Initiative (ICF) is to stop deforestation due to cocoa farming.

The 2018-2020 pilot phase demonstrated significant gains, including policy, legislative and regulatory changes in the forestry sector and the implementation of agroforestry activities. These results were achieved on the one hand, thanks to the collaboration and consultation between the public institutions involved and, on the other hand, between public and private sector actors.

The ICF's action plan for the 2022-2025 period aims not only to consolidate the achievements of the pilot phase, but also to increase the impact of the actions initiated.

The major challenge remains the mobilization of the financial resources required for the successful implementation of the Cocoa and Forest Initiative, a challenge that the signatories of the Framework for Common Action (CAC) agreement intend to address.

In addition, special emphasis will be placed on operationalizing the Unified National Cocoa Traceability System and the National Forest Monitoring and Deforestation Early Warning System. All these instruments are necessary to meet the requirements of the future European Union regulation on imported deforestation.

The first results of the collaboration between the signatories of the Cocoa and Forests Initiative are encouraging.

However, I invite the partners of the cocoa and chocolate industry in Côte d'Ivoire to be more involved in the sustainable management of forests.

I also invite all stakeholders of the Cocoa and Forest Initiative (WCF, IDH, cocoa and chocolate companies...) to join their efforts, alongside the Ivorian Government and technical and financial partners, to promote a sustainable cocoa economy that respects the environment and preserves the forest heritage, through the successful implementation of the ICF 2022-202 action plan.

While we have had much success on the ground, we know that we must accelerate and increase our investments and collaboration if we are to achieve our goal of eliminating deforestation and restoring degraded forests. We also need to develop collective actions and collaborations in priority forest landscapes, focusing on the most important areas most suitable for forest conservation and restoration. WCF and IDH will work together to mobilize all stakeholders to collectively invest in forest conservation and sustainable management in ICF priority landscapes.

MESSAGE OF IDH CHAIRMAN

2022 marked a turning point in the fight against deforestation in Côte d'Ivoire. The 15th session of the Conference of the Parties of the United Nations Convention to Combat Desertification (COP15) was held in Abidjan. The Ivorian government announced reinforced actions to restore its forest cover to 20% (at least) by 2030 and thus meet its commitments in this area. This announcement comes at a critical time for the global cocoa industry, as the imminent entry into force of the new European Union regulation on imported deforestation will affect the cocoa market and the zero emission ambitions of cocoa and chocolate companies.

The momentum continued after COP15, so the momentum and sense of urgency for action remained tangible. At the highly successful and well-received Cocoa and Forest Initiative (ICF) side event held at COP27 in Egypt in 2022, the strong representation from the lvorian government and private sector partners gave a clear message of dedication to the success of the Initiative and left no doubt about the commitment of partners to the ICF and their shared willingness to take meaningful action.

The Cocoa and Forests Initiative is an unprecedented public-private partnership, ideally positioned to combat deforestation by combining policy dialogue and on-the-ground investments. The commitment and perseverance of all signatories must be commended, especially as the urgency to act continues to grow.

This 2022-2025 action plan marks the beginning of the ICF second phase. Over the past five years (5), the ICF signatories, with the support of the World Cocoa Foundation (WCF) and IDH, have succeeded in establishing a strong public-private partnership that facilitates policy dialogue and promotes joint interventions.

A solid foundation has been established, with renewed forest management policies and a national cocoa traceability system underway. Companies have fully integrated ICF into the scaling up of agroforestry and the deployment of traceability systems. It is now time to take ICF to the next level: collective action must be at the heart of the way forward.

I would like to emphasize how important it is that this commitment, on the part of the ICF signatories, be seen by the international community. We have a strong foundation, now it's time to make a bigger impact. Stronger public sector ownership should lead to clearer policies and stronger enforcement. Greater transparency on the part of the private sector should enable real collective action and joint investment. From all sides, much more investment needs to be mobilized, not only from signatories but also from external partners. We need partners who will hold hands to get out of their comfort zone and do more. This action plan is an invitation to focus on implementing the commitment, and that is where all energy must now be channeled.

As IDH, we will continue to provide support for the ICF success and stand ready to leverage our extensive experience in mobilizing investments for sustainable landscapes across a wide range of geographies and value chains. We are delighted to see that the ICF Signatories have committed to focusing their collective actions around Côte d'Ivoire's key forest relics. Positive impact for forest conservation and restoration requires a clear vision and shared goals, supported by good governance and sound financial management, but most importantly, the inclusion of thousands of cocoa farmers and their communities

Specifically, the initiative focuses on forest protection and restoration, agroforestry and sustainable cocoa production, social inclusion and community **1. 

INTRODUCTION



Context

Since its independence, Côte d'Ivoire's economy has been based on sectors that put a lot of pressure on forest resources, led by the agricultural sector.

Thus, the country's primary forest has been progressively transformed into a mosaic of secondary forests, cash crop plantations, food crops and wastelands.

Forest cover has declined from 12 million hectares in 1960 to 7.9 million hectares in 1990. to 3.4 million hectares in 2015 and to 2.97 million hectares in 2021.

Over the past two decades, sustainability issues in the agricultural sector have evolved. For stakeholders, the priority issues are :

- The fight against climate change ;
- The respect of national and international environmental and social standards (and regulations) in the production systems of agricultural commodities;
- The availability of information on the origin and production conditions of products.

Cocoa, of which Côte d'Ivoire is the world's leading producer, is the main engine of the country's economic growth. It accounts for approximately 22% of its GDP and more than 50% of its export earnings (Conseil Café Cacao).

Unfortunately, Côte d'Ivoire's performance in cocoa production has been to the detriment of its forestry heritage. Indeed, cocoa farming is one of the major causes of the degradation of the lvorian forests. In order to reverse the deforestation trend, the Governments of Côte d'Ivoire and Ghana and about thirty companies in the cocoa and chocolate sector signed the

Framework for Common Action (CAF) of the Cocoa and Forests Initiative (CFI), in November 2017, on the sidelines of COP 23, in Bonn (in Germany).

These various signatories have made it their mission to eliminate deforestation in the cocoa supply chain.

In 2018, the government of Côte d'Ivoire and its cocoa industry partners translated the CAC commitments into an implementation plan covering a three-year transitional period (2018-2020), called the pilot phase. At the end of this pilot phase, satisfactory results were recorded, including :

- The reform of the legislative and regulatory framework of the forestry sector with the adoption of the new forestry code on July 23th, 2019;
- The strengthening of the mapping of the supply chain ;
- The promotion of agroforestry ;
- The launch of the project to set up a unified national cocoa traceability system;
- The adoption of a satellite-based forest monitoring system within the framework of the ICF.

However, certain challenges remain to be met, notably: the strengthening of forest protection and restoration with more assertive contributions from the private sector and technical and financial partners, the finalization of the project to set up a unified national cocoa traceability system, the operationalization of the national forest monitoring system and the effective mobilization of financial resources to fund the initiative's activities.

Main objectives

The main objective of this action plan is to contribute to the realization of the commitments made by the Ivorian government and the cocoa and chocolate industry to work together to halt deforestation and promote forest protection and restoration in the cocoa supply chain in Côte d'Ivoire, as outlined in the ICF's Framework for Common Action.

It is in line with the Ivorian government's ambitions to move towards sustainable cocoa and to contribute to the restoration of the national forest cover to at least 20% by 2030, as outlined in the National Development Plan (PND), the National Action Plan on Climate Change (PANCC), the Strategy for the Preservation, Restoration and Extension of Forests (SPREF), the Nationally Determined Contributions (CDN) and the Abidjan Initiative presented by the Government at COP 15. It also takes into account the new EU regulation on deforestation.

This action plan will help the government and its private sector partners pursue the common goal of reducing greenhouse gas (GHG) emissions from deforestation and forest degradation, maintaining cocoa productivity without additional forest conversion, reducing poverty, and helping conserve biodiversity.

Methodology

Approach

A multi-sectoral participatory approach was adopted to involve a wide range of stakeholders in the development of this action plan (Ministry of Water and Forests, the Coffee and Cocoa Council, Ministry of Environment and Sustainable Development, the Forest Development Company, the Ivorian Office of Parks and Reserves, the World Cocoa Foundation, technical and financial partners of Côte d'Ivoire, Civil Society organizations, etc.). It was articulated around the following steps:

- Collection and analysis of available documents on the ICF and related initiatives;
- Consultation with ICF stakeholders.

- Development of a draft 2022-2025 ICF Action Plan ;
- Consideration of stakeholder feedback and development of the final ICF 2022-2025 Action Plan document within the framework of this document.

Policy Alignment

This action plan takes a coordinated and strategic approach to aligning ICF activities with the various programs and policies of the government (the National Development Plan, the Forest Preservation and Restoration Strategy, the vision of recovering 20% of the forest estate by 2030), the chocolate and cocoa industry, and the National REDD+ Strategy, in order to ensure ownership of programs and activities, harmonization of the sector, and coordinated implementation of activities to optimize results.

At the international level, this action plan is aligned with the various international treaties and conventions that Côte d'Ivoire has signed and ratified. These include the Convention on Biological Diversity, the United Nations Convention to Combat Desertification, whose 15th Conference of the Parties was held in Abidjan from May 9 to 20, 2022, the New York Declaration on Forests and the Paris Agreement of 2015.

Il these agreements aim to enable Côte d'Ivoire to reduce greenhouse gas emissions, preserve biological diversity, promote fair and equitable sharing of benefits arising from the use of genetic resources and support livelihoods as alternatives to deforestation motivated by poverty and basic needs. These conventions have been translated into national policies, which currently guide national development and resource allocation.

At the national level, this action plan is aligned with the forestry policy, which is expected to achieve a forest cover of at least 20% of the national territory by 2030, compared to the current less than 10% by 2021, and the environmental policy, which has as one of its key objectives for 2030 the reduction of GES emissions by at least 55% compared to 1990 levels.



IMPLEMENTATION STRATEGY



In order to ensure successful implementation of this action plan, strategies and guiding principles have been defined as follows:

Public-private partnerships and collective action

This plan will emphasize large-scale implementation of activities through public-private partnerships/coalitions and joint action around pre-selected priority forests, parks and reserves and landscapes.

Multi-stakeholder involvement

The implementation of the 2022-2025 action plan will continue to follow a participatory process, including all stakeholders interested in achieving the set objectives. Relevant stakeholders, such as civil society organizations, local authorities, traditional authorities, farmers and farmers' organizations, and technical and financial partners, will play a crucial role at all levels of its implementation.

Regional approach

As in the previous implementation plan, there will be regular exchanges, sharing of lessons to set common guidelines to ensure replication and scaling up of successes in Côte d'Ivoire and Ghana, both signatories to the ICF.

Alignment with Existing Initiatives

Based on the ideology and value of maximizing resources and avoiding replication, the Cocoa and Forests Initiative will not seek to initiate new projects similar to existing ones but will continue to align with existing government and private sector efforts and initiatives by other stakeholders that seek to reduce deforestation, promote sustainable cocoa production and protect the environment.

Resource Mobilization and Funding

ICF will continue to work to create an enabling environment for private sector investment in forest protection to enable the mobilization of additional financial resources for the activities and actions required to implement the commitments made in the CAC. In addition, the Government of Côte d'Ivoire will help provide financial resources for the implementation of this plan, which will ensure the necessary financial support for implementation.

Between 2018 and 2020, the secretariat's activities were funded by donor agencies, in particular the Partnerships for Forests (P4F), the Government of the Netherlands, and other partners such as the World Bank, BUZA, and the Danish International Development Agency (DANIDA).

Implementation areas

In the first phase of the ICF (2018-2020), five priority regions were selected, based on criteria related to forest conservation, cocoa production, and population density. These are : Guémon, Cavally, Nawa, San Pedro and La Mé.


The second phase aims to go beyond this by promoting largescale projects conducted in a concerted effort by stakeholders from the public, private and civil society sectors. For a better impact on forests and farmers and to optimize the use of resources, the 2022-2025 action plan will also focus on priority classified forests, parks and reserves, located within the priority intervention areas:

The implementation process will first focus on identifying key stakeholders within the landscapes, raising their awareness of the ICF, and establishing partnerships. This will be followed by the development and implementation of integrated landscape management plans.



COCOA AND FORESTS INITIATIVE THEMES AND FOCUS AREAS: COMMITMENTS, ACTIONS AND ACTIVITIESS

The 2022-2025 ICF action plan is organized around the three key areas of the initiative in Côte d'Ivoire to ensure the sustainable management of forest and cocoa landscapes :

> Forest protection and restoration



Agroforestry and sustainable cocoa production



Community participation and social inclusion

Under each area, the plan includes objectives and activities, as presented below.

Area 1 : Forest protection and restoration: objectives and activities

The Ivorian State has opted for a forestry policy of which implementation strategy aims to increase the forest cover to 20% (at least) of the national territory by 2030 as opposed to 9.2% to date (for 2.97 million hectares), i.e. an increase of three (03) million hectares of forest.

It is with this in mind that ICF is working to ensure that the remaining forest area of Côte d'Ivoire is conserved, restored and rehabilitated.

The remaining forest relics are an integral part of the priority landscapes selected by ICF. These are the forests of the rural domain, protected areas and classified forests.

This area has one major objective, namely :

Objective 1 : Ensure the protection and restoration of selected classified forests and parks & reserves.

Two results will be sought :

• Result 1: Protection and restoration projects will be developed for collective investment by stakeholders in classified forests, parks and reserves.

It will also create an enabling environment for investments in forest protection and restoration, including clarification of the legal framework for carbon credit management and the creation of other incentives.

Result 2 : The satellite monitoring system adopted under the ICF (IMAGES) is operationalized and useful for strengthening protected area monitoring and enforcement actions, as appropriate ..

Area 2 : Agroforestry and sustainable cocoa production

This theme has a double objective :

(i) to guarantee zero deforestation cocoa production through the establishment of a national traceability system;

(ii) to produce more cocoa on less land while improving farmers' incomes, through the promotion of agroforestry, good agricultural practices (including climate change smart practices) and the diversification of income sources. Activities will also be conducted to strengthen land tenure security for farmers.

Objective 2 : Supporting the implementation of the national traceability system

The objective is to promote and maintain the quality of cocoa and to ensure that sustainably produced cocoa is traceable to its origin.

The traceability system will document the history of cocoa and track it through the supply chain. This activity is based on the census and identification (map) of farmers, the mapping of cocoa plots and the bagging at the field for export. This will develop transparency in the sector, in order to reduce transaction costs and increase profit margins for sustainably produced cocoa. This mechanism aims to trace the origin of cocoa beans from farms to ports, in order to protect forests and put an end to illegal plantations in protected areas; to secure and make reliable the recording of physical and financial flows at the edge of the field through the use of innovative and efficient technological solutions (bank or mobile payment of farmers).

The project is led at the national level by the Cocoa Council. ICF will facilitate consultation and collaboration between the different stakeholders for an efficient implementation of the national traceability system.

One result will be sought under this objective :

• Result 3 : A unified national traceability system is implemented.

Objective 3 : Promote agroforestry and sustainable production

This will involve promoting the development of agroforestry as a sustainable production mechanism, particularly in connection with the implementation of the African standard of the ARS 1000 series for sustainable cocoa. Agroforestry also plays a key role in the process of income diversification for producers and climate resilience / climate smart cocoa.

Two outcomes will be sought under this objective :

Result 4 : Agroforestry projects, integrating activities for the improvement of producers' income, are implemented. In addition to standardizing agroforestry as an approach to cocoa cultivation, these projects will contribute to the improvement of producers' income through support for the valorization of products from agroforestry systems, training and technical support for producers on the themes of good agricultural practices and agricultural entrepreneurship, community awareness (tree ownership, women's access to land, etc.), land tenure security and the development of incentive mechanisms (payments for environmental services, carbon finance, etc.). The first step in this outcome will be to conduct a baseline survey to collect information on current and future projects from ICF signatories, particularly the private sector. This will make it possible to quantify the objectives and impacts targeted by these actions and to expand their monitoring.

• Result 5 : Actors collaborate to promote agroforestry.


MONITORING AND EVALUATION

A monitoring-evaluation framework for the Initiative has been implemented by SEP-REDD+, the entity identified to ensure the implementation of monitoring-evaluation of the GSI. This framework will serve as a basis for the development of a monitoring and evaluation system integrated into the projects and activities conducted under this action plan.

INSTITUTIONAL AND GOVERNANCE ARRANGEMENTS

Institutional Roles and Responsibilities

The governance bodies of the Cocoa and Forests Initiative were established by an interministerial order issued on July 03rd, 2018.

The governance framework for the implementation of the ICF in Côte d'Ivoire includes a steering committee, a technical committee, working groups, a permanent secretariat, and a monitoring and evaluation body.

The Steering Committee is responsible for providing strategic guidance and impetus for the functioning of the governance bodies established in the CAC, validating the proposals made by the Technical Committee, ensuring governance in the process of implementing the Framework for Common Actions.

The Technical Committee is responsible for coordinating the effective implementation of the actions defined in the CAC, supervising the work of the various working groups and validating their action plans, making proposals received by the Steering Committee, preparing the various meetings of the Steering Committee.

The Permanent Secretariat is responsible for preparing and organizing the meetings of the Steering Committee and the Technical Committee, assisting the signatories in the preparation and implementation of the Action Plan, coordinating funding mobilization activities, preparing progress reports, ensuring the sharing of information among all the stakeholders of the Cocoa-Forests Initiative, and mobilizing funding for the Initiative's operational functioning.

The Permanent Executive Secretariat of REDD+ monitors and evaluates progress at the national level and reports to the Technical Committee and the Steering Committee.

Operational activities are implemented by public structures (Ministry of Water and Forests, Conseil Café Cacao, etc.), private companies that are signatories to the ICF's Framework for Common Actions and civil society.

For a more dynamic initiative, a review of the current ICF governance will be proposed to make it more flexible. This proposal will be made to the Steering Committee for validation and should result in the revision of the 2018 inter-ministerial order.

This revision will allow for greater collaboration between ICF member institutions.

Communication Plan

The 2022-2025 Action Plan will be accompanied by a communication strategy that will cover activities in both Ghana and Côte d'Ivoire.

This communication strategy will define the objectives, communication targets, key messages, communication tools and actions to be taken, including the management of the website dedicated to ICF activities. It will also define the branding strategy and communication rules to be followed by all Initiative partners.

Pending the definition of this strategy, it is expected that all ICF stakeholders will inform each other of any external communication that includes the promotion of the Initiative, and allow a reasonable period of time for feedback on the messages to be communicated.

This applies to all means of communication, including events, public presentations, interviews, blog posts, workshops, etc.

CONCLUSION

As a result of the consultations and analysis of the 2022-2025, six main priorities were identified, including :

- Selection of priority FCs and P&Rs and implementation of large-scale public-private projects to protect and restore selected landscapes : as already indicated, for the 2022-2025 action plan, priority will be given to selected classified forests, parks and reserves. For the successful implementation of ICF activities that are primarily related to forest protection, this activity will need to be carried out in a collaborative approach that ensures the commitment of all.
- Financing of the Initiative : to meet the challenges related to the mobilization of financing, it is necessary to initiate consultations, on the one hand, between the ICF partners and, on the other hand, with potential financial partners (private sector, donors, etc.) to agree on modalities for the mobilization and management of funds that inspire confidence and credibility.
- Effective and sustainable functioning of the Permanent Secretariat to ensure not only the holding of meetings, but also the monitoring of the implementation of commitments on the ground and the implementation of the 2022-2025 action plan. This will have to ensure a sustainable funding mechanism for the Secretariat.
- Satellite monitoring: Forest monitoring is a priority for achieving the ICF objectives. To this end, its implementation consists of two approaches: satellite monitoring and monitoring by agents in the field.



Satellite monitoring must be operationalized in order to be able to carry out targeted field monitoring based on alerts and data collected. In addition, initiative partners will need to ensure that the learnings from satellite monitoring under the ICF inform the process of establishing a national scale monitoring system that is being implemented.

 Traceability: the focus will be on monitoring the implementation of activities carried out by the Cocoa Coffee Council and the creation of a framework for consultation and exchange between the Council and all other partners in the initiative.

Landscape approaches (landscape management): The landscape approach aims to think of a territory in relation to the ecosystems that make it up and by taking into account the populations that live there and their interactions with these ecosystems.

It is thus necessary to involve the populations in the sustainable management of their environment and to put forward the gain for the populations to adopt an ecologically sustainable mode of development. Within the framework of the ICF, this approach will facilitate not only the execution of activities but also the sustainability of these implemented activities.

In addition to the involvement of the populations, the landscape approach makes it possible to identify and address in a more holistic way the environmental, social and economic challenges of a given landscape and to ensure a better coordination and an optimization of the synergies of the actions carried out in this landscape; and thus to optimize the impacts of interventions.
